**Propagation Host:**

CV-1 cells (ATCC® CCL-70™)

**Effect on Host:**

Lethal infection of rabbits in vivo. Pocks on CAM following inoculation of eggs. CPE in culture, including localized enlargement, vacuolation, degeneration and death of cells.

**Medium:**

EMEM (ATCC® 30-2003) + 2% FBS (ATCC® 30-2020)

**Growth Conditions**

**Recommendations for Infection:** For best results, plate cells 24 to 48 hours in advance. Infect at 80-90% confluence using a multiplicity of infection (MOI) of about 1. Incubate 2-3 days at 37°C in a humidified atmosphere of 5% CO<sub>2</sub> in air.

## Comments

Possible non-primate animal model for the study of smallpox. This virus has been fully sequenced (Li, G., et al.; GeneBank accession no. AY484669).
