**Propagation Host:**

mouse amnion cells; 1 day old mouse, i.c. inoculation

**Host of Choice:** HAm cells for TC, day-old mice, i.c. for mouse passage material

**Host Range:** sM, HAm, HED, HeLa cells. Adaptation may be necessary if passed from one host to another suckling mouse; human fetal diploid kidney cells; human diploid embryonic; HeLa cells (ATCC CCL-2). Adaptation may be necessary if passed from one host to another

Yes, in vitro effects: Cytopathic effects in tissue culture  
CPE (TC); death (sM)

Yes, in vivo effects: death in suckling mice

## Growth Conditions

Duration: 6-10 days

## Comments

Plaques containing rounded or dendritic cells with granular cytoplasm appear in secondary HAm cell cultures on the 6<sup>th</sup> day. Cell destruction maximal on the 10<sup>th</sup> day. CPE occurs in HeLa and in HED cell cultures. It is recommended that for maximum titer, both brain and limb be harvested, and mice not older than one day be employed for titrations.
