Medium: EMEM (ATCC® 30-2003) + 2 µg/mL TPCK-treated trypsin + 0.2% BSA fraction V + 25 mM HEPES buffer

Growth Conditions

Temperature: 35°C

Recommendations for Infection: Plate cells 24-48 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g. 0.01). Adsorb 1-2 hours at 35°C in a humidified 5% CO₂ atmosphere, rocking every 15 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

Incubation: 2-3 days
