**Temperature:** 37°C

**Recommendations for Infection:** Plate cells 24-48 hours prior to infection and infect when cultures are 80-85% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted to provide an optimal MOI (e.g. 0.01). Adsorb 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 10-15 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 2-4 days
