Effect on Host: CPE, refractile rounding and sloughing

DMEM (ATCC® 30-2002™) + 5% FBS (ATCC® 30-2020™)

Growth Conditions

Temperature: 37°C

Recommendations for Infection: Plate cells 18-24 hours prior to infection and infect when cultures are 60-80% confluent. Remove medium and inoculate with a small volume of virus (e.g. 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g. 0.1). Adsorb 1-2 hours at 37°C in a humidified 5% CO₂ atmosphere. End adsorption by adding virus growth medium.

Incubation: 4-7 days at 37°C in a humidified 5% CO₂ atmosphere, until CPE is progressed through 80% of the monolayer.

Comments

ATCC® VR-1838PQ™ is a high-titer, live virus suspended in culture medium. This product was prepared from ATCC® VR-1838™ via concentration by centrifugal filtration.
