Growth Conditions
Temperature: 33°C

Recommendations for Infection: Plate cells 18-24 hours prior to infection and infect when cultures are 80-90% confluent. Remove medium and inoculate with a small volume of virus (e.g., 1 mL per 25 cm²) diluted to provide an optimal MOI (e.g., 1.0). Adsorb 1.5-2.0 hours at 33°C in a humidified 5% CO₂ atmosphere on a rocking platform. End adsorption by adding virus growth medium.

Incubation: 3-5 days at 33°C in a humidified 5% CO₂ atmosphere on a rocking platform, until CPE is progressed through 80% of the monolayer.

ATCC® VR-1875™ was derived from ATCC® VR-515™ following treatment with diethyl ether to remove mycoplasma contamination.
