## Growth Conditions

**Temperature:** 37°C

**Recommendations for Infection:** For best results, infection should be performed on a 70-80% confluent, 18-48 hour old cellular monolayer. Prepare dilution of virus in minimum amount of volume (e.g. 1 mL per 25 cm<sup>2</sup>). Wash monolayer with PBS or serum free medium prior to inoculation. Adsorb virus dilution for 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 2-4 days at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed through 80% of the monolayer.

## Comments

FCV-2280 is not neutralized by antiserum to the vaccine strains FCV-M8, FCV-F9 and FCV-255. This virus has been adapted to tissue culture propagation and may not readily infect cats. Note: This material is cited in a U.S. and/or other Patent and may not be used to infringe on the patent claims.
