**Propagation Host:**

**Effect on Host:**

No CPE produced. Presence of virus determined by immunofluorescence or by double sandwich ELISA assay.

**Medium:**

DMEM (ATCC® 30-2002™) + 3% FBS (ATCC® 30-2020™) + 4 mM L-Glutamine (ATCC® 30-2214™)

**Growth Conditions**

**Temperature:** 32°C

**Recommendations for Infection:** Plate cells 24-48 hours prior to infection and infect when cultures are 90% confluent. Remove CGM and then wash monolayer once with 1X DPBS (ATCC® 30-2200™). Inoculate with a small volume of virus (e.g. 1 mL per 25 cm<sup>2</sup>) diluted in plain DMEM to provide an optimal MOI (e.g. 0.001). Adsorb 2-2.5 hours at 32°C in a humidified 5% CO<sub>2</sub> atmosphere, rotating on a roller apparatus at 0.75 RPM. End adsorption by adding virus growth medium.

**Incubation:** Incubate infected culture for 21 days at 32°C in a humidified 5% CO<sub>2</sub> atmosphere on a roller apparatus at 0.75 RPM.
