### Propagation Host:

MDBK (NBL-1) cells (ATCC® CCL-22™)

### Effect on Host:

CPE, cell rounding with vacuolization, clumping, and sloughing

### Medium:

EMEM (ATCC® 30-2003™) + 2% HS (ATCC® 30-2041™)

### Growth Conditions

**Temperature:** 37°C

**Recommendations for Infection:** For best results, infection should be performed on a 70-80% confluent, 18-48 hour old cellular monolayer. Prepare dilution of virus in minimum amount of volume (e.g. 1 mL per 25 cm<sup>2</sup>). Wash monolayer with PBS or serum free medium prior to inoculation. Adsorb virus dilution for 1-2 hours at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, rocking every 20-30 minutes to redistribute inoculum. End adsorption by adding virus growth medium.

**Incubation:** 4-10 days at 37°C in a humidified 5% CO<sub>2</sub> atmosphere, until CPE is progressed through 80% of the monolayer.

## Comments

REFERENCE STRAIN: Pereira HG et al. A short description of the Adenovirus group. *Virology* 20: 613-620, 1963.

Agglutinates rat RBC. CPE may be minimal, frequently demonstrating less than 25% involvement of cell sheet, even with prolonged incubation. AAV reported to be present.
