Comments

Not described in the original publication, but presumed to have been selected after mutagenesis with nitrosoguanidine and replication in the presence of bromodeoxyuridine. The non-permissive incubation temperature is 39.5°C. This mutant was not assigned to a Dales EM category. The mutation was assigned by complementation analysis (Lackner, et al, 2003) to vaccinia virus map location A24, the 132 kDa RNA polymerase subunit.
