This microorganism does not closely resemble other rickettsiae, psittacosis-like agents, or other well-characterized organisms. Spherical particle, 0.5 micron in diameter. It has not been cultivated on cell-free medium. Inactivated at 56°C in 10 minutes; titer reduced at 37°C in 14 hours and at 0°C in 6 weeks. Growth is inhibited by broad-range antibiotics and by p-aminobenzoic acid. Antigenic for rabbits. Not antigenically related to other microorganisms. Stable at 60°C. Type strain.
