Description

Source: Human herpesvirus 5

Designation: Genomic DNA from HCMV strain AD-169 [ATCC® VR-538™]

Description: Viral nucleic acids, including virus genomic DNA, in total DNA isolated from MRC-5 cells (ATCC® CCL-171™) infected with Human herpesvirus 5 (HCMV) strain AD-169 (ATCC® VR-538™). Virus and host cells are also available through the ATCC® Catalog. This product was prepared using methods known to inactivate viruses.

Note: DNA isolated from virally infected cells is appropriate for PCR and other molecular virology applications.

Batch-Specific Information

Refer to the Certificate of Analysis for batch-specific test results.

Preparation Procedure

1. Thaw the vial at room temperature and immediately place on ice. Avoid exposing the DNA to repeated freeze-thaw cycles as it may result in degradation of the DNA.
2. Gently mix the sample to ensure an even distribution of material.
3. Briefly centrifuge the tube before opening to ensure all liquid is at the bottom.

Quality Control Information

1. Store at -20°C or colder. -80°C or vapor-phase liquid nitrogen (-196°C) is preferred for long-term storage (more than one month).
2. Concentration is verified as > 1 µg/mL DNA by Picogreen® assay.
3. Purity is confirmed by OD₂₆₀/OD₂₈₀ ratio (> 1.7) of bulk DNA prior to dilution for product filling.
4. Integrity is inferred from observation of high molecular weight cellular DNA following electrophoresis 20 µL of product on a 0.8% agarose gel, visualized by ethidium bromide staining.
5. Functional activity is demonstrated by PCR amplification of a 500-3,000 bp amplicon using virus-specific primers.
6. Identity is confirmed by sequencing of ~300 base pairs of the PCR amplicon.
7. Absence of infectious virus is verified by incubation of 10% of each lot with susceptible host cells under appropriate conditions for a period of 7-14 days.
