Comments

Will not grow in RhK cells. Must be cultivated at 33-35°C, will not grow at 37°C. Has group antigen for Poxvirus, crosses slightly with vaccinia and monkeypox and is less stable. Does not hemagglutinate. BS-C-1 cells slowly develop cytoplasmic eosinophilic inclusions.
