**Temperature:** 37°C

**Recommendations for Infection:** For best results cells should be 24 to 48 hours old and 80% - 90% confluent (not 100% confluent).

**Incubation:** 2 to 3 days at 37°C, a 5% CO<sub>2</sub> in air atmosphere is recommended.

### Comments

Depends upon helper adenovirus type 2 (ATCC® VR-846™) for replication. Helper virus may be inactivated at 56°C for 30 minutes.
