The CEID<sub>50</sub> is the dilution of virus that under the conditions of the assay can be expected to infect 50% of the chicken embryos inoculated, just as a Lethal Dose 50% (LD<sub>50</sub>) is expected to kill half of the animals exposed. A reciprocal of the dilution required to yield the CEID<sub>50</sub> provides a measure of the titer (or infectivity) of a virus preparation.
